Washington's New All-Payer Claims Database

In 2014, the Legislature established the Washington all payer claims database (WA-APCD) to collect all medical, dental, and pharmacy claims from private and public payers, with data from all settings of care that permit the systemic analysis of health care delivery.

The purpose of the database is to improve health care price transparency and to:

- Assist patients, providers, and hospitals to make informed choices about care
- Enable providers, hospitals, and communities to improve by benchmarking their performance against that of others by focusing on best practice
- Enable purchasers to identify value, build expectations into their purchasing strategy, and reward improvements over time
- Promote competition based on quality and cost
- Learn about the content and rules for use of the database, and how it can be helpful to your advocacy.
