

STAFF ATTORNEY – Northwest Health Law Advocates

Northwest Health Law Advocates (NoHLA) is a Seattle-based non-profit organization that works to achieve accessible and affordable health care for all through policy and legal advocacy, public education and support to community-based organizations in Washington State. Founded in 1999, NoHLA is a leader of consumer advocacy on health care issues.

We are seeking a full-time Staff Attorney with a strong commitment to racial and social justice to engage in advocacy on behalf of health care consumers. The work will be in Washington State with opportunities to collaborate with advocates on a local, state, and national level.

The Staff Attorney will perform the following functions:

- Work with NoHLA attorneys, staff and other health advocates to develop and advocate for innovative strategies and policy solutions at the state and local levels.
- Advocate at the state and national levels, to influence policies concerning access to health care
 and the rights of health care consumers. Coordinate and lead in initiatives in collaboration with
 other health advocates. Participate in health care coalitions, task forces and working groups.
- Research and draft position papers, reports and materials aimed at policymakers and the general public with a focus on health equity and access to care.
- Respond to inquiries and requests for assistance and case consultations from legal services and private bar members, health and community advocates and policy makers.
- Prepare and deliver trainings, public presentations, and media on a wide array of health carerelated issues, accessible to a wide and diverse audience.
- Engage in legal research, litigation, and amicus briefing.
- Assist with organizational fundraising and reporting related to the above activities.

Qualifications

Minimum requirements:

- J.D. degree from an accredited law school
- Admission to Washington State Bar or willingness to take next bar exam
- Ability to work independently and as part of a team with staff, lawyers, coalition partners, community groups, and others
- Strong interpersonal and communication (oral and written) skills with a variety of audiences
- Strong writing and analytical skills, including capacity for independent research
- Knowledge of health care and coverage access laws, policies, and/or programs including Medicaid
- Lived or work experience with diverse communities
- Commitment to equitable access to affordable, quality health care for all
- Proficiency with Microsoft Office Suite and Google tools
- Ability to engage in in-state work-related travel after the pandemic



Preference will be given to candidates with:

- At least 5 years' legal or policy experience (at least three years in health care, public benefits, and/or civil rights advocacy)
- Experience in litigation, representation of low-income clients, health policy work, and/or public health
- Experience directly serving a diverse client base or audience
- Oral and written proficiency in one or more non-English languages

NoHLA is committed to dismantling structural oppression and promoting diversity and equity within and outside our organization. Candidates who identify as people of color, immigrants, people with disabilities, veterans, women, or LGBTQ+ are encouraged to apply.

Commitment, Compensation and Benefits

- Full-time, starting immediately
- Salary range \$75,000 \$83,000 annually commensurate with experience; generous health and retirement benefits
