Re: 59 Organizations Request Governor's Budget Investment In Immigrant Health Equity

Dear Governor Inslee, Director Sullivan, and Senior Policy Advisor Voris:

The undersigned 59 organizations respectfully request that the Governor's final budget prioritize funding for health coverage for immigrant communities in the 2025-2027 biennium. We thank you for your leadership over the years and ask that you secure your legacy as a champion for equitable access to health coverage for all Washingtonians with further investment in the immigrant communities who are essential to the strength of our state. **As you know, many Washingtonians go without essential health care because they are structurally excluded from affordable health coverage today**.

With your leadership, Washington took historic steps this year to expand health access by both launching Apple Health Expansion, a Medicaid-like program for adults with incomes up to 138% FPL, who are excluded from federal support, and opening Washington Healthplanfinder to all Washingtonians. Current funding has allowed over 12,000 low-income adults to access Apple Health and for over 2,000 to purchase qualified health plans for the first time. However, these individuals are only a small fraction of the immigrant communities in Washington who are income-eligible for our new state programs; the vast majority of low-income Washington immigrant adults continue to suffer from a lack of sufficient health coverage.

To ensure these programs provide meaningful affordability assistance, we ask that the Governor's 2025-2027 biennial budget include the following:

(1) Programmatic and operational funds to expand the Apple Health Expansion program for eligible adults with income up to 138% of the federal poverty line who are ineligible for other federally subsidized health care programs. While Washington made significant advances this year, over 8,000 eligible individuals have been denied as of 20 September due solely to capped funds. Additionally, between October 2023 and June 2024, over 18,000 individuals entered their information into Healthplanfinder and appeared to be eligible for AHE. However, less than 20 percent of those individuals were able to secure a spot in the program. OFM estimates over 35,000 Washingtonians are eligible, but HCA reports current funding only provides coverage to 12,000 – about 1 in 3 eligible individuals. We appreciate HCA's request for additional AHE funding as their second priority of 53 requests; however, the proposed additional 4,000 spaces in HCA's decision package request for 2025 will cover fewer than half of those who have *already* been denied due to the cap. Our top priority is for the Governor's budget to demonstrate a stronger commitment to health equity with adequate AHE funding to cover more eligible Washingtonians and at minimum accept the HCA's decision package request. Additionally, the Governor's budget can lay the foundation for future advancement with modest investments:

(2) Accountability to communities is essential to addressing disparities.

The Health Care Authority has worked with the Health Benefit Exchange and the Department of Social and Health Services to convene a Temporary Community Engagement Advisory Committee to weigh in on aspects of the new immigrant programs. Given the health disparities and historic marginalization endured by immigrant communities, it is crucial for this committee to transition to a permanent accountability committee that provides meaningful insight into and oversight of both AHE and the newly expanded access to qualified health plans on Washington Healthplanfinder. The Accountability Committee should have the resources to evaluate and improve services provided, network adequacy, and quality measures as well as providing accountability.

(3) Identifying strategies to address remaining equity gaps in affordability on

Washington's state exchange. While 1 in 3 newly eligible Washington immigrants shopped for health coverage on the exchange since the 2023 open enrollment, *fewer than 1 in 20* of those Washingtonians purchased coverage indicating significant premium affordability barriers. While Cascade Care Savings has been critical to overall affordability for Washingtonians and needs to be preserved, its current structure is deeply regressive for immigrants by utilizing a flat cap so an individual with no income or an individual with \$36,000 annual income will receive the same dollar amount. Older adults face more expensive premiums but do not have any additional assistance. Although lawfully present immigrants under the federal 5-year bar and DACA recipients can now access federal premium assistance, cost sharing is almost \$10,000 for an individual in addition to premiums and \$20,000 for a family – this is unworkable for those with the lowest incomes. We request one-time funding for an HBE study exploring the best way to resolve inequities in premium and cost-sharing assistance in the future.

(4) Identifying long-term care needs crucial to health. We remain deeply concerned that Apple Health Expansion does not currently include long-term care as a benefit unlike other Apple Health programs. We continue to advocate for long-term care coverage as part of AHE program in the future. For this budget cycle we ask that the budget include a one-time DSHS study to explore coverage needs for individuals who are currently on the waitlist for the state's existing capped long term care program for undocumented immigrants as well as those eligible for the AHE but presently unable to access long-term care.

Today our first priority is preserving and improving health access through Apple Health Expansion. Even in sobering economic conditions, you have an opportunity to establish the groundwork for addressing unmet needs when finances improve – which they will because we are stronger when we all have the opportunity to thrive. We urge you to use your last Governor's budget to build a lasting legacy for health equity.

Thank you for your previous support of health coverage for immigrant communities. Please embrace this opportunity to ensure that the Governor's budget provides the needed funding to continue Washington's status as a national leader in providing equitable access to health care for every Washingtonian.
